

KORE GROUP HOLDINGS, INC.

NOMINATING AND CORPORATE GOVERNANCE COMMITTEE CHARTER

(As of September 30, 2021)

I. Purpose

The purpose of the Nominating and Corporate Governance Committee (the “*Committee*”) is to identify individuals qualified to become members of the Board of Directors (the “*Board*”) of KORE Group Holdings, Inc. (the “*Corporation*”) consistent with criteria approved by the Board, to recommend that the Board select the director nominees for the next annual meeting of stockholders, to develop and recommend to the Board the Corporate Governance Guidelines (as defined herein) and to oversee the evaluation of the Board.

II. Composition

The Committee must consist of at least three directors, each of whom must satisfy the independence requirements of the listing standards of the New York Stock Exchange, subject to any available exception. Committee members must be appointed and may be removed, with or without cause, by the Board. Unless a Chair of the Committee is designated by the Board, the Committee may designate a Chair of the Committee by majority vote of the full Committee membership.

III. Meetings, Procedures and Authority

The Committee has the authority to establish its own rules and procedures for notice and conduct of its meetings so long as they are not inconsistent with any provisions of the Corporation’s bylaws that are applicable to the Committee.

The Committee has sole authority to retain and terminate any search firm to be used to identify director candidates, including sole authority to approve such search firm’s fees and other retention terms. The Committee has the authority to retain any other advisors that the Committee believes to be desirable and appropriate and has the authority to approve related fees and retention terms.

In addition to the duties and responsibilities expressly delegated to the Committee in this Charter, the Committee may exercise any other powers and carry out any other responsibilities consistent with this Charter, the purposes of the Committee, and the Corporation’s bylaws.

IV. Duties and Responsibilities

1. *Director Nominees.* The Committee will identify individuals qualified to become members of the Board and ensure that the Board has the requisite expertise and that its membership consists of persons with sufficiently diverse and independent backgrounds. The

Committee will also recommend to the Board the nominees for election to the Board at the next annual meeting of stockholders.

2. *Director Independence.* To develop and recommend to the Board for approval standards for determining whether a director is independent.

3. *Criteria for Selecting Directors.* The criteria to be used by the Committee in recommending directors and by the Board in nominating directors are as set forth in the Corporation's corporate governance guidelines (the "*Corporate Governance Guidelines*").

4. *Board Committee Structure and Membership.* The Committee will annually review the Board committee structure and recommend to the Board for its approval directors to serve as members of each committee.

5. *Board Leadership Structure.* The Committee shall periodically review the Board leadership structure and recommend to the Board for its approval changes to its leadership structure, including a Chair of the Board if appropriate.

6. *Corporate Governance Guidelines.* The Committee will develop and recommend to the Board the Corporate Governance Guidelines. The Committee will, from time to time as it deems appropriate, review and reassess the adequacy of such Corporate Governance Guidelines and recommend any proposed changes to the Board for approval.

7. *Board Evaluation.* The Committee will oversee the periodic self-evaluations of the Board and its committees.

8. *Shareholder Engagement.* To oversee engagement with stockholders and proxy advisory firms, and to review proxy advisory firm policies and voting recommendations.

9. *Third Party Director Nomination Rights.* Committee oversight of director nominations shall not apply in cases where the right to nominate a director legally belongs to a third party.

10. *Corporate Governance Disclosure:* To review and discuss with management disclosure of the Corporation's corporate governance practices, including information regarding the operations of the Committee and other Board committees, director independence and the director nominations process, and to recommend that this disclosure be included in the Company's proxy statement or annual report on Form 10-K, as applicable.

11. *Environmental, Social and Governance ("ESG") Matters:* To review and monitor the development and implementation of the goals the Corporation may establish from time to time with respect to its ESG and sustainability matters, and provide guidance to the Board on such matters.

12. *Corporate Governance Trends.* To review emerging corporate governance trends, best practices and regulations applicable to the corporate governance of the Corporation.

13. *Other Corporate Governance Matters.* The Committee may make recommendations to the Board regarding governance matters, including, but not limited to, the Corporation's certificate of incorporation, bylaws, and the charters of the Corporation's other committees.

14. *Reports to the Board of Directors.* The Committee must report regularly to the Board regarding the activities of the Committee.

15. *Committee Self-Evaluation.* The Committee must periodically perform an evaluation of the performance of the Committee.

16. *Review of this Charter.* The Committee must periodically review and reassess this Charter and submit any recommended changes to the Board for its consideration.

V. Delegation of Duties

In fulfilling its responsibilities, the Committee has the authority to delegate any or all of its responsibilities to a subcommittee of the Committee.
